## **EXERCISING RIGHTS and DATA CONTROLLER**

Complying with law in force, at any time you might:

- Be informed regarding your data presence
- Know origin, content, goals and process pattern.
- Logic underlying electronic treatment
- Details of Controller, Processor, Parties whom your data have been communicated to Moreover you have the right of:
  - Update, integrate, correct your data and rights of portability
